The Shoshone-Bannock Tribes are proposing to enact **Permitting Regulations**. The Permitting Regulations will implement sections of the **Shoshone-Bannock Tribes Waste Management Act**.

Written comments will be received for a period of thirty days. Copies of the proposed **Regulations** may be picked up during regular business hours at the Tribal Attorney Office, located at the Tribal Business Center on Pima Drive, Fort Hall, ID. All comments should be submitted to the Shoshone-Bannock Tribes, Tribal Attorney's office and received on or before August 9, 2010.

RESOLUTION

WHEREAS, the Tribal Land Use Environmental Waste Management Program requests approval for adoption and enactment of the Shoshone-Bannock Tribes Environmental Waste Management Program Permit Regulations to implement section 211 of the Waste Management Act revised July 1, 2010; and

WHEREAS, the Permit Regulations will be used to regulate waste treatment, storage, and disposal facilities on the Fort Hall Reservation in order to protect human health and the environment; and

WHEREAS, the Permit Regulations will be used to regulate waste treatment, storage and disposal facilities including locations on the Fort Hall Reservation in order to protect human health, the environment and resources; and


WHEREAS, the Shoshone-Bannock Tribes (Tribes) have submitted Permitting Regulations to implement the Tribal Waste Management Act for Public comment on one prior occasion; and

WHEREAS, the Tribes have reconciled those public comments and amended the Permitting Regulations;

NOW, THEREFORE BE IT RESOLVED BY THE FORT HALL BUSINESS COUNCIL OF THE SHOSHONE-BANNOCK TRIBES, that the Tribal Land Use Environmental Waste Management Program request is hereby approved and adopts the Shoshone-Bannock Tribes Environmental Waste Management Program Permitting Regulations Revised July 1, 2010 effective immediately subject to a thirty (30) day additional public comment period.

Authority for the foregoing resolution is found in the Indian Reorganization Act of June 18, 1934 (48 Stat., 984), as amended under Article VI, Sections 1 (a, r) of the Constitution and Bylaws of the Shoshone-Bannock Tribes of the Fort Hall Indian Reservation of Idaho.


